 - Disability Insurance (DB120.1)
- Nassau or Suffolk County Consumer Affairs or Valid Contractor's License
- Dumping License (or in absence of one, a prior invoice from your dumping location)
- Driver's Licenses for all individuals operating a vehicle
- Valid Registration for all vehicles

I have read Chapter 125, "Licensing" of the Village of Baxter Estates Village Code and agree to abide by the provisions thereof, and the following rules & regulations of the Village of Baxter Estates:

- WORK IS PERMITTED MONDAY – FRIDAY, 8:30AM-6PM AND SATURDAYS, 9AM-6PM. NO WORK IS PERMITTED ON SUNDAYS OR FEDERAL HOLIDAYS.
- LEAVES & YARD WASTE MAY NOT BE BLOWN ONTO VILLAGE STREETS.
- THERE IS NO DUMPING ALLOWED ON VILLAGE STREETS OR VILLAGE PARKLAND.
- DURING THE VILLAGE'S LEAF PICK-UP SERVICE PERIOD, LEAVES MAY ONLY BE PLACED ON THE VILLAGE'S RIGHT OF WAY BETWEEN THE PRIVATE PROPERTY OWNER'S PROPERTY LINE AND THE CURB, PROVIDED THAT SIDEWALKS MUST BE MAINTAINED CLEAR OF LEAVES. BRANCHES ARE NOT TO BE INCLUDED WITHIN LEAF PILES. PLEASE CHECK WITH THE VILLAGE CLERK'S OFFICE AS TO THE DATES OF THE VILLAGE'S LEAF PICK-UP SERVICE PERIOD, AS THEY ARE SUBJECT TO CHANGE.
- GROUNDSKEEPERS MUST COMPLY WITH THE RULES AND REGULATIONS OF THE PORT WASHINGTON GARBAGE DISTRICT.
- ANY TRIMMING OR REMOVAL OF CLASS "B" TREES MUST SATISFY THE VILLAGE'S TREE REMOVAL PERMIT AND OTHER REQUIREMENTS UNDER VILLAGE CODE CHAPTER 161.
- EVERY GROUNDSKEEPER VEHICLE USED IN THE VILLAGE MUST HAVE VILLAGE OF BAXTER ESTATES REGISTRATION STICKER ON REAR BUMPER.
